### From the Webmaster . . . Harvey Powers

What a great Conference we had in Haysville last month. A great turnout. Good program. And lots of opportunities to renew friendships. Many thanks to Steve Eller for his work.

The next Conference is tentatively scheduled for July 19-22, 2023. I know it's a long way off but please mark it in your calendars and put a bug in the ear of family members who might be inclined to come. It is critical that we start

involving the next generation if we want to see the EFA continue.

I believe it's also critical that we expand interest beyond the Jacob Eller line. As a result, the membership approved the suggestion we hold the 2023 Conference in the Bloomington, Indiana, area (Monroe County) in 2023.

John Eller (1786-1840) and his wife, Susan Smith Eller (1788-1867), moved to Monroe County from Kentucky with their family, including his mother, Christina Yost Eller (1755-1844), about 1832.

They settled on the Eller Farm (about 400 acres) five miles west of Bloomington. John was a Justice of the Peace and a Probate Judge. He was the grandson of Christian Eller.

We've documented nearly a thousand of John's descendants but I was the only one at this year's Conference. I may be optimistic, but with the Conference in the Monroe County area, I hope we can improve on that.

It won't be the first "reunion" for

the Indiana Ellers. A 1901 <u>clipping from the Bloomington Telephone</u> refers to the "…annual reunion of the Eller family. It is always held at what is known as the Eller burying ground, 6 miles west of the city, on the well-known Eller farm…" Much of the "Eller farm" was sold for the Monroe County Airport.

If you have family in Indiana, please send me their name and email so I can start trying to recruit them for the conference.

I hope to have a Christian Eller book ready by 2023. Donn Koenig has already researched a great deal of the George Eller, Jr. (1777-1851) line and I've been working on the book as well. Because it will be hundreds of pages, I believe the book will be available only on CD. The information is available elsewhere in this publication.

## **Board/Directors Meeting Minutes**

The July 15, 2021 Board/Directors meeting started at 4:00pm EDT. In conjunction with the Members meeting at the EFA Conference, those Board and Directors present were Lauren Liggett, Dan Liggett, Ed Eller, Harvey Powers, Anna Bliss, Steve Eller, Jerry Kendall, Emily Cook, and David Eller. Corrine Casper was unable to attend the conference.

During the morning Members session, Steve Eller was elected as the new President and Lauren Liggett was elected as the new Secretary/Treasurer with Anna Bliss remaining as the Vice President and the Editor (Dan Liggett) and Webmaster (Harvey Powers) remaining the same as well.

After some debate over whether the next conference should be in Dalton, GA or Monroe County, IN, it was decided to hold the July 2023 EFA Family Conference in Monroe County, IN with Harvey Powers hosting. Concerns expressed included the possibility of losing attendees with a more distant location than recent conferences. The hope is to attract more than "regular" participants and hopefully non-John Jacob Eller lines will be better represented.

Ed Eller gave his financial report in the morning member session, which will be listed after these minutes.

The proposed EFA By-Laws changes were approved by the Members in the morning session, so the finished version will be listed after these minutes.

Steve reported he now has over 22,000 records in his update of the John Jacob Eller book.

In the April Board meeting, it was suggested that we need to locate a male descendant from the Roanoke Ellers (Jacob Eller line, primarily in Salem, VA these days) who would be willing to donate his DNA to the Eller Family Project. From that DNA, we should be able to determine whether or not they connect with any of the known Eller lines (see a series of articles on the Roanoke Ellers beginning with the May 1988 Eller Chronicles). As a result of asking for a volunteer in the May 2021 Chronicles, we now have a volunteer that fits that scenario. The new secretary/treasurer Lauren Liggett will arrange to have a DNA kit sent to him.

The meeting was adjourned at 4:30pm EDT.

## **EFA By-Laws**

After the vote at the EFA Member meeting on July 15, 2021:

## OFFICIAL BY-LAWS Of THE ELLER FAMILY ASSOCIATION

#### **ARTICLE I - NAME**

The name of this non-profit association shall be THE ELLER FAMILY ASSOCIATION.

#### **ARTICLE II - STATEMENT OF PURPOSE**

The purpose of the ELLER FAMILY ASSOCIATION shall be:

- 1. To promote a sense of kinship and a consciousness of ELLER history and tradition.
- 2. To promote and publicize local family reunions.
- 3. To hold a biennial family conference open to all ELLER and allied family members worldwide.
- 4. To encourage the restoration and maintenance of cemeteries or other sites of meaning to various ELLER families.
- 5. To encourage and aid genealogical and historical research on ELLER and allied families worldwide.
- 6. To encourage and assist in the publication of ELLER family histories and ELLER related genealogies.
- 7. To publish THE ELLER CHRONICLES, which shall be the official publication of the Association.

#### **ARTICLE III - MEMBERSHIP**

- 1. Membership in THE ELLER FAMILY ASSOCIATION (hereafter EFA) shall be open to all persons and organizations subscribing to its purposes and has paid dues to date.
- 2. Any member may withdraw from membership by filing resignation with the Secretary of EFA, or by non-payment of dues.
- 3. Any member may be removed, with or without cause, at any meeting by a two-thirds vote of the members in attendance at a duly constituted general membership meeting.

#### **ARTICLE IV - DUES AND MEMBERSHIP**

- 1. Annual dues shall be set by the Board of Directors and shall be due on the anniversary date of joining the EFA. Membership dues shall include four quarterly issues of the ELLER CHRONICLES. Back issues of THE ELLER CHRONICLES shall be made available to members and non-members at a cost set by the Board of Directors.
- 2. Charter Members are those who were accepted for membership prior to November 1, 1988.
- 3. Donor Members are those who contribute \$35.00 annually.
- 4. Sustaining Members are those who contribute \$100.00 annually.
- 5. Honorary Life Members are those recognized by the Board of Directors for outstanding contributions to the EFA. They are exempt from annual dues. Life Members are those who have paid Life Membership dues.
- 6. Contributions are amounts paid beyond the amount of dues required for membership, and shall be acceptable at any time. Contributions may be designated by the donor for any EFA approved project of donor's choice.

#### **ARTICLE V - MEETINGS**

- 1. Regular meetings of the EFA membership shall be held every other year in conjunction with the Eller Family Conference, the time and place designated by the Board of Directors. The goal will be to hold meetings in the East, West, and Middle regions of the U. S.
- 2. Any meeting of the EFA membership shall be duly constituted when the following criteria are met:
  - a. No less than 4 states are represented.
  - b. A quorum shall consist of 10 members, including at least three members of the Board of Directors.

- 3. The general membership meeting of EFA shall include the election of officers and board members, the President's annual report, and other business as may properly come before the meeting.
- 4. Notice of any EFA meeting shall:
  - a. Be announced in THE ELLER CHRONICLES.
  - b. Shall be postmarked at least 60 days prior to the scheduled date if sent by mail.
  - c. Include a proposed budget, and an agenda approved by the Board of Directors. The agenda will be adhered to at all membership meetings.
- 5. Meetings of the Board of Directors shall be held as provided in Article VII.

#### **ARTICLE VI - OFFICERS**

- 1. The officers of the EFA shall consist of a President, Vice President and Secretary-Treasurer.
- 2. Officers shall be members in good standing and shall also serve as members of the Board of Directors. Officers and Directors shall serve for a term of two years, and thereafter shall be eligible to be reelected to the same office upon the approval of the Board and election by the members.
- 3. Nominations for office shall:
  - a. Be made by a committee of three or more members appointed by the President at least six months prior to the regular biennial meeting.
  - b. Be made from the floor at general membership meetings.
  - c. Be made by any member contacting the President, in writing, with a petition signed by at least (5) members requesting a named member be placed in nomination and included on the ballot.
  - d. Nominees must sign a statement agreeing to serve prior to being nominated from the floor or by written petition.
- 4. A vacancy in any office shall be filled by the Board of Directors <u>prior</u> to *serve until* the next general membership meeting.
- 5. The duties of the officers shall be substantially as provided herein, with such other duties as may be assigned by the Board.
  - a. The President shall:
    - 1) Preside over the meetings of the Board of Directors *and* the general meetings of the EFA membership.
    - 2) Carry out the policies of the EFA as established by the Board of Directors.
    - 3) Appoint project coordinators and support their efforts.
    - 4) Appoint committees and send a complete list of all committees to the secretary to be retained in the minutes book.
  - b. The Vice President shall:
    - 1) Fulfill the duties of the President in the latter's absence.
    - 2) Shall promote the policies and projects of the EFA.
  - c. The Secretary/Treasurer shall:
    - 1) Record and transcribe the minutes of all general membership meetings of the EFA, and maintain a permanent minute book.
    - 2) Maintain a current roster of the membership of the EFA
    - 3) Be the custodian of all official records exclusive of those pertaining to the responsibilities of the Editor of THE ELLER CHRONICLES.
    - 4) Receive all inquiries to the EFA other than those specifically directed to other officers or members of the Board.
    - 5) Be the principal accounting and financial officer of the Association. He/She shall have charge of and be responsible for the maintenance of adequate books of account, have charge and custody of all funds and securities received for and in the name of the EFA from any source and be responsible for the disbursement thereof. Any exception from this procedure shall require unanimous consent of the Board of Directors.
    - 6) Make annual financial reports to the EFA membership in THE ELLER CHRONICLES, August issue, which immediately follows the end of the fiscal year (Jul 31).

#### **ARTICLE VII - BOARD OF DIRECTORS**

- 1. The officers, elected or appointed directors, the Editor of THE ELLER CHRONICLES and the EFA Webmaster shall constitute the Board of Directors.
- 2. The term of service governing officers shall apply to all members of the Board of Directors.
- 3. The Board of Directors shall:
  - a. Meet quarterly by phone, if feasible, and every other year in person in conjunction with the general meeting.
  - b. Establish policies that govern all matters that pertain to the business and operation of the EFA and approve all programs and projects that advance the purposes of the EFA.
  - c. Authorize the expenditure of monies for duly approved projects to further the purposes of EFA.
- 4. Authorize and fund a review of the financial records of the Association as deemed appropriate by the Board.
- 5. A quorum of the Board shall consist of four Board members including at least one officer. Minutes of all Board meetings shall be published in THE ELLER CHRONICLES. Board meetings shall be open to all members of EFA.

#### **ARTICLE VIII - COMMITTEES**

A committee shall be defined as a group appointed by the President or Board of Directors to accomplish a specific goal, such as the "Nominating Committee".

Project Coordinators shall be defined as one member appointed by the President or Board of Directors to perform a specific task, such as "coordinate the biennial conference". A project coordinator may seek the advice and help of any other member of the EFA in carrying out an assignment.

- 1. The President shall:
  - a. Establish such committees as he or the board deem necessary. He shall assign their mission, and limit their size and tenure. A committee shall be dissolved when its mission has been accomplished, or upon the expiration of its designated term.
  - b. Appoint project coordinators to coordinate the efforts of many members to accomplish an assigned task that might require more than the efforts of a committee.

#### **ARTICLE IX - AMENDMENTS**

Amendments to the bylaws may be proposed by the Board at a general meeting for approval by the membership. Provisional amendments to the By-Laws may be agreed upon and deemed "in effect" by the Board of Directors in an official Board meeting, but they will not be made a permanent amendment until voted on by the membership at the next bi-annual EFA Member meeting.

#### **ARTICLE X - DISSOLUTION**

Upon the dissolution of THE ELLER FAMILY ASSOCIATION and/or the final completion of its business affairs, the remaining assets of the Association shall be distributed in the following manner:

- 1. Funding for professional research in the Eller Family Lines in Germany and surrounding areas relevant to American Eller Family lines to be administered by a committee of at least 2 EFA members. Results to be added to the EFA Archives and Website where appropriate.
- 2. The upkeep of the ELLER FAMILY ASSOCIATION ARCHIVES, located at the Rowan County Library, Salisbury, North Carolina.
- 3. The upkeep of the EFA website: <a href="www.ellerfamilyassociation.com">www.ellerfamilyassociation.com</a>
- 4. The upkeep of the Eller Family Project with Family Tree DNA (<a href="https://www.familytreedna.com/groups/eller/about">https://www.familytreedna.com/groups/eller/about</a>)







# **History in Stitches**

by Jerry Taylor

(part of Jerry Taylor's talk at the EFA Conference concerned a quilt commemorating the history of Towns County, GA. The following are his notes from that that quilt discussion)



A replica of Towns County's sesquicentennial quilt

This quilt was designed by Thomas Quilla Bradley, Barbara Bone and Pat Meinecke and quilted by the Misty Mountain Quilters (partners-in-education) Sharp Memorial Methodist Church as a teaching tool for Towns County history in our elementary school. It was created in celebration of the Towns County Sesquicentennial in 2006.

Notice the yellow ribbon serving as a timeline. Follow the path, beginning with the horse and wagon, and answer the following questions.

#### 1. What highway did many of the early settlers follow into this area?

Prior to the existence of a toll road from the Tellico Block House to the Tugaloo River known as the Unicoi Turnpike a path existed over the entire route of the turnpike. In general, this was known as a Cherokee Trading Path.

Generally, the Trading Path that became the Unicoi Turnpike began at Tellico Block House on the Federal Road between Ramhurst and Knoxville, entered the Tennessee mountains at Unicoi Gap and traveled east to the area of present-day Murphy, North Carolina. From here the path turned south, followed the Hiawassee River to its headwaters just below the northern entrance to Georgia's Unicoi Gap.

Once through Unicoi Gap the path generally followed Spoilcane Creek to the ,Chattahoochee River. As it dropped some 800 feet from Unicoi Gap towards Sautee, the road crossed Spoilcane Creek and Chattahoochee River 11 times, basically creating switchbacks for people who used the trail.

Once it was in the Sautee-Nacoochee Valley the road continued east as the Chattahoochee turned south. The Sautee Store is built on the site where a road from The Crossings (present-day Clayton, Georgia) met the Unicoi Turnpike. This road was also part of the Cherokee Trading Path network and joined roads to present-day Virginia, Maryland and Pennsylvania.

From Sautee-Nacoochee to Toccoa the road passed through the northeast Georgia Mountains and reached Travelers Rest Historic Site.

Gen. James R. Wyly built the road, completing it in 1819. Many structures on the Unicoi Turnpike, including the Nachoochee Inn and at least 2 other inns were also built by Wyly. Depending on the terrain, these inns were 13 to 20 miles apart (a day's travel). In 1820 he built a brick home along the road north of Unicoi Gap. In this area of Towns County, the road was also known as Wyly Road. (Note: The old Brown house on the River.)

#### 2. Why did the early pioneers come to north Georgia in the 1820s and 1830s?

Get rich quick- "There's gold in them thar hills ... "

And these illegal alien ancestors of ours (in the Cherokee Nation) coveted the Cherokee land ultimately resulting in Pres. Andrew Jackson's removal of the Cherokees to the West in 1838.

A popular song in Georgia at the time included this refrain:

All I ask in this creation
Is a pretty little wife and a big plantation
Way up yonder in the Cherokee Nation.

#### 3. What material did the pioneers use to build their houses?

Log cabins

#### 4. Who are those people who appear to be leaving the area?

Group led by Carey Waldrip trying to get the Georgia portion of UT designated with "Toff status"-turned down so far as current policy only allows the Ton network to begin at forts- closest fort was at Hayesville known as Fort Hembree, previously known as Hiwassee. And the truth is that by the removal in 1838 only a handful of Cherokee remained in Towns, having been scared off by our illegal alien ancestors and the Georgia militia did not protect the Cherokee as they were supposed to.

#### 5. What is the oldest church (1835) organized in our county?

Macedonia Baptist Church

#### 6. When was Towns County formed?

1856 from Union and Rabun

Went from upper Upper Hightower to the traffic light on hwy 515 at Morganton before coming into Blue Ridge, with Blairsville as county seat - The story is that the citizens wanted a courthouse that they could get to and do their legal business (vote, pay taxes etc) and get back home before dark.

#### 7. Of which two counties had it been a part?

Union and Rabun

#### 8. What is the name of the zig-zag in Towns County's northern border?

Montgomery Corner, 5 miles northeast, on the Georgia-North Carolina line, marks the southern end of a half mile of the State boundary line. It was established in 1818, by J. Camack and H. Montgomery, to mark the end of a survey run east from the corner of Georgia, Alabama, Tennessee, along what was thought to be the 35th parallel.

#### 9. What historical event is suggested by the cannon?

The unCivil War

#### **Stitches in Time**

COMMUNITY, NEWS June 24, 2019, by Towns Co Content Specialist

HIAWASSEE, Ga. – On Friday, June 21, Historian Jerry Taylor led the Mountain Movers and Shakers on a journey through Towns County's heritage, as depicted on an artistic quilt designed to wind its path from past to present. The 2006 quilt was woven in honor of Towns County's 150 anniversary by Misty Mountain Quilters Guild, and it is currently displayed as a teaching tool for educators at Towns County Elementary School. Taylor began the presentation by explaining that the golden thread that weaves its way around the quilt represents the Unicoi Turnpike which once served as a trade route through Cherokee territory.

The historian directed the group's attention to the patches within the quilt, beginning with the arrival of newcomers who sought fabled wealth through gold mining, the forced removal of the <a href="Cherokee tribe">Cherokee tribe</a> on the infamous Trail of Tears, the formation of Towns as a county entity, the turmoil of the "un-Civil" War, the establishment of the area's oldest chapel — <a href="Macedonia Baptist Church">Macedonia Baptist Church</a> -and the origins of education. The voyage continued with the history of the logging industry which stripped virgin forests near <a href="Tate City">Tate City</a> bare, the introduction of information through a local printing press, the trade of illicit moonshine, the arrival of the <a href="Appalachian Trail">Appalachian Trail</a>, and the creation of Lake Chatuge through the Tennessee Valley Authority. The tale continued with the construction of the county's premiere hospital, the foundation of <a href="Brasstown Bald">Brasstown Bald</a> as a state park, and lastly, the influx of settlers during the modern age of communication. The blazing, seven-pointed star represents the Cherokee clans, Taylor said, and the four corners of the quilt honor the Appalachian tradition of quilting itself.

Taylor shared colorful stories of families of old along the way, entertaining listeners with his range of knowledge. Mountain Movers and Shakers gather each Friday at 8 a.m. at Sundance Grill. Community speakers inform the open public on a variety of topics of interest.

## A Visit With Hermon Eller

Hermon Eller was the son of Floyd Ray Eller and Della Arizona Eller. Floyd Ray goes back to Susannah "Sukey" Eller through her son, Jacob. Della Arizona goes back to Susannah "Sukey" Eller through her son, Joseph.

On 10 June 2021, I visited my distant cousin Hermon Eller on Upper Hightower in Eastern Towns County, Georgia.

Hermon told me a story about his family raising hogs. The family used to let their hogs roam the mountains up on Charlie's Creek Road close to Flat Branch. Every week Hermon and his mother (Della) would load up burlap sacks with corn and walk from their home to Flat Branch to feed the hogs. This was probably about a six or seven mile walk and mostly up hill. Other times during the week, the hogs fed off weeds and acorns. The hogs wore bells on their collar so they would be easier to find. Sometimes the hogs would have piglets and they would tag along behind their mother. Hermon remarked, "We would just call them ... sooey pig sooey and they would all come runnin".

Several years ago, we were walking around Charlie's Creek trying to find my great grandfather's (Hardy Washington Eller) old home place and Leon Berrong (an Eller Descendant) found an old bell on the ground. He also explained that people used to let their hogs run wild in the mountains and that this was one of the bells.

Hermon was the brother of Jewell Jay Eller who was found guilty of murdering Milton Melvin Maney in 1947. I have heard many versions of this story. Hermon has one that was told to him by his brother: Jewell Eller and Charlie Garrett (a cousin to Jewell) were trying to make a little money and went up to Milton Maney's house to see about making a deal on cutting some dogwood trees. It seems as if dogwood lumber was at a premium during this time as it was used to make furniture. Milton had helped them sharpen an axe and they were all on the front porch. Charlie Garrett had been drinking and all of a sudden picked up the ax and hit Milton with it. Jewell told Hermon that he didn't know that Charlie was going to do that. Milton was in a lot of pain and dying. Wanting to keep Milton from suffering anymore, Jewell stepped up and hit Milton again. Jewell and Charlie died in the Georgia Electric Chair on 5 November 1948. Their last words warned of drinking alcohol and that it was the reason they were in the electric chair. Since no one else was there, we may never know or be able to uncover what really happened. I thought Hermon deserved his version told just as much as anyone.

There is a road that turns off Upper Hightower Road just south of Hermon's house. This road is now named "Parks Road" but it used to be called Maney Road since Milton Maney was the only person living on this road. Hermon explained that a Parks man moved in from somewhere and lived there several years and when the county started putting up road signs, they named it Parks Road. It's a shame that the Maney History was taken away from the area. It would be great if some how the county could change the name back to Maney or Parks/Maney Road.

Hermon's mother used to cook meals for Milton after his wife passed. Milton's wife was Missouri Mae Eller. Mae had 16 children and passed away at age 48. Missouri Mae Eller goes back to Susannah "Sukey" Eller through her son Joseph and Mariah Hedden Eller. I had wondered why

Hermon's mother cooked meals for Milton, so I did a little research and found out that Della's mother was Margaret Caroline Maney and a cousin to Milton.


Hermon had mentioned to me several times that his name was spelled "Hermon" and not "Herman". During this visit he was very chatty and told me why. His mother was reading the Bible before he was born and she came across Psalms 133:3. I went straight home and looked it up. "As the dew of Hermon, and as the dew that descended upon the mountains of Zion for there the LORD commanded the blessing, even life forever more".

As I drove away that day, I was thinking about my ancestors in these North Georgia Mountains and how lucky I was to be connected to this beautiful Blue Ridge Region.

# Eller Descendant Was a "Flying Tiger" in WWII

Andrew Jackson "Jack" Gadberry (1921-1997) was a member of the famous "Flying Tigers" unit in World War II.

Jack Gadberry was the Great-Great Grandson of Susan Elizabeth Eller (1814-1835) and is from the Christian Eller line (found here on the EFA website):

(Jack - Andrew Jackson Sr. - James Wiley - Andrew Jackson - Susan Elizabeth - George Jr. - Rev. George – Christian (Crissy)).

Jack Gadberry enlisted in the Army Air Corps Reserve 11 Jun 1942 and was called to pilot training in March 1943.

The original "Flying Tigers" under Claire Lee Chennault (1941-1942) was actually the "First American Volunteer Group (AVG)" of the Republic of China Air Force. They were composed of pilots from the United States Army Air Corps, Navy, Marine and Corps, recruited under President Franklin Roosevelt's authority before Pearl Harbor. Their Curtis P-40B Warhawk aircraft,



marked with Chinese colors, flew under American control. Their mission was to bomb Japan and defend the Republic of China.

After July 1942, when Jack Gadberry served, the original unit was incorporated into the Army Air Corps as the 75<sup>th</sup> Fighter Squadron but retained the "Flying Tigers" name. Gadberry was assigned to that unit at Kwelin and Chihkiang. He flew 16 missions in P-40's and 19 missions in P-51's. He was shot down over Hengyang in November 1944 but

Gadberry was released from active duty in May 1946 but was recalled in 1951. He served until his retirement in 1968. Following his military service, he worked as a civilian engineer at Wright Patterson Air Force Base in Ohio.





Father's wife then had a son, who kept them on the run. And he became my grandson, for he was my daughter's son.


My wife is now my mother's mother, and it makes me blue. Because, although she is my wife, she's my grandma too.





James Hook printed the first work on the Eller genealogy in 1925 titled: James Hook and Virginia Eller. He printed the second edition on the Eller family after thirty-two years titled: George Michael Eller and Descendants of His in America. Strong evidence showing George Michael to the son of Georg Eller of Kaltenbrunn, Untermerzbach, Bavaria exists, showing George as the second son of the union of Georg and Margaretha Huels Eller.

Margaretha Eleonor Sallén began researching the Eller lineage in 1966 until her death in 1973 when it continued with David until completed and printed in late 2012. Each chapter focuses on nine generations of these figureheads: George Michael Eller, James Scott, John Martin, Sr., William Gallaway, Robert Harper, Sr., William Smith Bryan, and John R. Stewart.
