From Ben Eller:

Henry Eller, Sr. traveled to America from his home in the Palatinate, Germany with four brothers according to historian Jim Eller and records that recorded travelers from Germany through England to America. All five brothers, being in their 20's, traveled from Rotterdam to England then on to America. Henry arrived on the ship Neptune on October 25, 1746, and is believed to be the youngest. Henry's decedence moved from the original American home in Germantown (near Philadelphia), Pennsylvania to Washington County, Maryland. Later many of his decedence moved to Ohio, moving westward into Indiana. Henry was named co-executor of his brother, George Michael's will, executed on October 26, 1779 in Frederick County, Maryland, along with Michael Gerber.

HENRY ELLER SR.

It is known, and documented, that Henry Eller Sr. arrived into this country aboard the "Neptune" on October 25, 1746 in Philadelphia. Henry took his oath of allegiance the same day. He and his wife, Elizabeth Bigler Eller were baptized April 14, 1754 by Elder Michael Franz of the Conalico Congregation of Lancaster County, Pennsylvania, Concalico District. Henry was a member of the German Brethren Baptist, which was also called Dunkard.

In a book of genealogy by James Hook, and his wife Virginia Eller Hook, it tells of the churches built near the ELLER farm where HENRY

ELLER SR. and his family lived: "...the original Dunkard migration to America in 1719, and in 1725, they had formed their first church in Germantown, Pennsylvania. By 1729 there was a church at Constiga, some 15 miles south of Lancaster County, Pennsylvania where HENRY ELLER SR. and his wife were baptized on April 14, 1753. Later still the Piper Creek Church was formed at Union Bridge in Carroll County, Maryland; 2 miles N.E. of the ELLER farm; and the Beaver Dam Congregation of Piper Creek, which was 2 1/2 miles from HENRY ELLER'S farm."

From Will Book B, Page 194, Case #1127:

"In he name of God, Amen; I Henry Eller of Montgomery County and the state of Ohio being sick and weak in body but of perfect mind, memory, and understanding, and knowing that it is appointed for all men once to die do make and ordain this my last will and testament in manner and form as followeth to wit vir. First I do give and commend to the earth to be buried in decent Christian burial. And as touching this worldly estate I give and dispose of the following manner. First I do that my just debts and funeral expences shall be paid out of my estate, and further is my will that all the money now in my hands at my decease shall remain in the hands of my beloved wife as long as she remains my widow and after her decease the whole of my estate shall be equally divided among all my children., and further those of all my children that have given their receipt for the sum of one hundred and fifty dollars as part advance of my estate for which they have engaged

themselves to pay interest for that amount yearly. Now it is my will
after my decease, and after the decease of my beloved wife those
interest shall cease and the prinipal shall be accounted for with each
part of share of said Estate. And if any shall neglect to pay interest
by the said receipts back or such part as those that have neglected to
pay, so much they shall have before an equal division is made, and
lastly I constitute and appoint my son Daniel Eller and my son in law
Jacob Albaugh to be he Excutors of This my last will and testament
ratify in this and no other to be my last will and testament. In witness
where I have herein to set my hand and seal this fifth day of January
Anoro Domini 1832.

"ELLERS came into Randolph Township about 1806....Robert and James
Ewing, John and Abraham McClintock came from Kentucky in 1805. David
and William Skeets came from North Carolina in 1806. About this time
settlements sprang from every part of the township. Jacob Smith settled
on the Northeast quarter of section 19; David Kinsey on the Northeast
quarter of section 32; Daniel Fetters on section 29, Peter Fetters on

section 21, both in 1806. The ELLERS and the Fouts came about the same year. In 1811, there was a heavy immigration from Pennsylvania. Rasors, Warners, and Braunbaughs, with others came and all of them opened clearings for themselves...."

(note: Warners and Braunbaughs were to become cousin families through marriage with Eller's in this and other generations.)

ADDITIONS TO HENRY ELLER JR.

Found in Hagerstown, Maryland: H/657 Deed...pertains to the settlement of the estate of Henry Eller (Jr.), deceased, recorded April 21, 1794, naming his children....

Found in Washington County, Maryland: Land Record M 12, pages 462 and 463, recorded April 25, 1800...finally received the forty pounds due him from the estate, as he is now of lawful age. (The youngest son of Henry-Peter Eller).

In the history of Washington County, Pennsylvania published in 1882, under Biographical Sketches of the many Pioneers and Prominent Men by Boyd Crumrine: a paragraph pertaining to Peter Eller who came to West Bethlehem Township soon after 1800 and purchased land. At the time of publication (1882) mentioned was made that Peter's son Henry lived on the tract of land. Further there is a record of "Memorandum of an agreement" assigned the widow and heirs of Peter Eller late of West Bethlehem Township, Washington County, Pennsylvania, deceased, etc. leaving no will, dated May ? 1843. The administrators were Daniel Eller and Nicholas Garret. Signatures of persons receiving their distributive share were: Mary Magdeline Eller, Widow an children Mary Eller, Henry Eller, Katherine Eller, and Elizabeth Eller. This Peter Eller may be the youngest son of Henry Eller Sr.; if so, Daniel Eller might be his older brother.

The 1850 census of Randolph Township, Montgomery County, Ohio reports that Daniel and Elizabeth were both born in Maryland. The 1860 census of the same township shows that they were born in Pennsylvania.

(the different reports may be explained with the changes of state borders of Pennsylvania and Maryland. In some documents Washington County is shown in Pennsylvania instead of Maryland.)

On August 8, 1814 Daniel Eller bought the NE quarter section of section 6 in Randolph Township, Montgomery County, Ohio totaling 160 acres. It appears that he still retained the tract in 1850 as his real estate was valued at six thousand dollars at the time.

Of the Joseph Eller (1808–1864), his estate was settled in 1871; and to the heirs of DANIEL ELLER (Joseph was Daniel's brother) went 1/80th of the estate to wit: Moses Eller, Margret Kinsey, Arron Eller, Daniel Eller, Henry Eller, Sarah Warner, Susanna Smith, Fanny Dohner, Elizabeth Rodney (Elizabeth Rodney is in a wrong list of heirs pertaining to the issues of Henry Eller III receiving 1/60th)

Daniel Eller is shown in the 1820 federal census, reference # 101.

FAMILY HISTORY OF DANIEL S. ELLER

"In the late 1850's Daniel S. Eller and his wife, Francis, and five of his children migrated from Montgomery County, Ohio. According to marriage dates he left here shortly after his marriage to Francis Swank. Before he came to Montgomery County, Ohio he lived in Maryland. He married Rachel Mote. They were married in Miami County, Ohio and settled in Montgomery County, Ohio. In Montgomery County, Ohio I find only a marriage to Francis Swank 27 March 1851. His first wife died 9 April 1850 and in 1851 he married Francis Swank. They left here by wagon train shortly after his second marriage. William A. Eller was the only child born to his first marriage. In the wagon train were people who could make up or start a new village comprised of a blacksmith, carpenter, miller, and other people necessary to the care of people and their health and progress. They settled somewhere in Missouri and owned farmland, but this I cannot prove as the records were all burned of the

Deeds in 1911. During the Civil War the Confederate soldiers came and burned all their wheat fields and Aaron, William remembered looking back and seeing the stalks of grain burning in the fields. The people took what possessions they had and started back to Ohio. They suffered many hardships and two of Daniel's children were buried along the way, Ira Calvin and Amanda Jane. Daniel related he felt so sorry to have to leave them there. They were buried in a wood box made by the men, no grave marker or anything else to remember them by. They came back as far as St. Louis, Missouri and by that time were without food. They met Martin Eller, a cousin of Daniel's, who directed them to a fort where they could get food to see them through. Martin related to his grandson, Wayne Eller, how one of his oxen had died and left him with one ox, which he couldn't pull his wagon. He confiscated a cow from one of the people on the wagon train. She didn't like the idea and they got into an argument. She was standing by the campfire heating water and became so enraged she threw the hot water on him. They left St. Louis, Missouri and came on to Illinois and then back to Gordon, Ohio where they lived until the end of their days. Theodore Eller was born to Daniel and Francis coming back on the wagon train. Daniel Eller was a farmer owning land adjoining the Studebaker Farm in Preble County, Ohio. Aaron owned the farm after Daniel's death as related by Cletus Weisenbarger (his father owned the adjoining farm.). These were all farms near Gordon, Ohio. Wayne Eller said Daniel was married to a Rachel Mote. Jan 1969, had a letter stating Daniel Eller married Rachel Mote in Miami County, Ohio, June 6, 1847. Wayne said, from Mrs. Nolan L. Jeff; January 27, 1969--information says they migrated to Cedar County, Missouri.

"In 1746 Jacob Gebel (Cable) arrived in this country from

Switzerland. He seemed to have lived in Franklin County, Pennsylvania

where his son Martin was born about 1750. Martin was married about

1773 in Brudersthal (Brother's Valley) Pennsylvania in what later became

Sommerset County. He married Christiana Replay or Ripley; and on her

death probably about 27 years later; he married Mary ?. To him was born

16 children; four sons and twelve daughters. From 1773 to 1808 he lived respectively, in what later became Somerset, Cambria, Blair, Westmore, and again back in Cambria County. He was a German Baptist preacher (now the Church of the Brethren). In about 1808, he moved that portion of his family that still lived at home to Perry Township, Montgomery County, Ohio; his older children including the oldest son Christian and four daughters remaining in Pennsylvania and one daughter remaining in Athes County, Ohio, where they had lived several years previously. Martin died on his land about eight miles west of Dayton on or near November 25, 1811. The thirteenth child, Martin, was born near Frankstown, Pennsylvania in the northern part of what is now Blair County, November 15, 1795. In Montgomery County, Ohio he married Elizabeth Creviston on March 17, 1817. They lived on the family land west of Dayton at least until after Mary Ann Cable (Eller) was born; then moved up to Miami County about 25 miles north and bought a farm about a half mile north of where the village of Bradford was later established (1861), and lived there until early 1850. In early 1850, this Martin Cable moved his family still at home to Grant County, Indiana (note from compiler, J.M. Eller: this gives a strong reason for Ellers, including Henry & Mary Ann Eller, John Eller, ect. to locate in this area. At one time Henry and Mary Ann had their children and grandchildren + living there.) and then soon up to Sommerset in Wabash County, the next county north, where he was elected to the ministry in the German Baptist Brethren Church and was a circuit rider. Martin died August 17, 1861 unusually heavy; his height was 5'6"...."

JOHN ELLER

HARRIET (HATTIE) MILLER ELLER

On September 24, 1861 at Anderson, Indiana John Eller, at the age of 19, was enrolled by Captain Lawshe into the Union Army. On October 10, 1861, in the same city, Lt. Col. Wood mustered Private John Eller into the "Lawshe Company". Later the unit became Company K of the 34th Indiana Volunteer Infantry Regiment.

As a teamster and ambulance driver, Private Eller was described as: a blue eyed, brown haired Ohio farmer who was five foot eight inches tall with fair complexion.

The Company Descriptive Book states that in November 1862 John was with an expedition down the Mississippi River, and later in January 1863 he was with an Ambulance Corps, 3rd Brigade of the 2nd Division D.E. Arkansas. In April and May John Eller was on medical leave due to an injury; but he returned and was again attached to an ambulance corp. from July 1863 through September 1863.

John re-enlisted December 14, 1863 and was given a one hundred dollar re-enlistment bonus.

In February 1864 he received leave at Cavallo, Texas where he received four hundred dollars in pay and was due three installments of fifty dollars.

In July 1864 Private John Eller was attached aboard the "Eliza" by order of R.B. Jones. He later returned to his unit. He was discharged in Brownsville, Texas on February 3, 1866.

John was given a military pension as a war veteran with the file record of Pension 343-522.

according to the Rocklake Golden Anniversary Book, July 29,30, 1955:

Listed as one of the early homesteaders and settlers in Rocklake, North Dakota. John lived on his homestead near his also pioneering relatives, including his brother Mahlen, his son Ader E., and his father Henry.

"Rocklake was incorporated as a village on the 28th day of April 1906. The election was also held on that date and the vote was 27 to 1 for incorporating. JOHN ELLER and E.E. Brooks were the inspectors of the election and J.L. Thompson was clerk. The election was held in the

Lichty Hall. Following is a list of the voters: L.G. Eastman, W.J.

Lichty, S.U. Treadwell, Cal Lapha, F. Lasher, J.L. Thompson, JOHN ELLER,
E.E. Brooks, W.B. Wiley, Frank Barnes, Thos. S. Wiley, Frank Eldredge,

"End of the Ripples....

The end of the Rocklake paper was occasioned by an event that every
early resident recalls. many petty grievances had built up until the
day in 1910 when the one more incident became the one too many. S.U.
Treadwell marched into Bill's crowded pool room brandishing a revolver,
and when John Diggins and Mr. Hill tucked down behind the bar, he
reached over the bar and shot one through the shoulder and one through
the neck.

Treadwell returned to his newspaper office only to find that his
keys had been stolen, so he returned to Jahnke's Store, where an exited

group had gathered to discuss the happening. He, still carrying a gun, requested the proprietor to go in the pool hall and get his keys. By the time all the men had dropped under counters and stuck out the back door, leaving but one person still sitting on the counter, and this a woman, MRS. COY ELLER. However, when Treadwell went to the hotel to ?, Ma Keeney asked him for his gun 'before someone gets shot' and he gave it to her readily. The victims recovered and Treadwell was requested to leave the state."

Also enclosed in the book:

"This first post office was located north of the present town in Rock Lake Township, Section 29, in the northwest quarter on the Johnson Homestead. The mail was carried twice a week on Tuesdays and Saturdays from Perth to Rocklake. Bill Wiley was the first star route carrier by contract but he, having only one arm, was afraid to carry the mail during the winter, and he turned the contract over to ADER ELLER who carried the route mostly by horseback across the prairies.

When the railroad was built in 1905 the post office was moved into town and was located for about three months in the building that later became Jahnke Bros. Store. That fall a small building was moved in from the ELLER FARM and it was located on Main Street near Ripples office, and the post office was moved there. In 1907 when the new brick bank building was completed the post office was moved into the building vacated by the bank, where it has been located ever since, with the exception of the short period during Mr. Lehman's term when it was moved across the street.

The first post master in the new town was JOHN ELLER, with his son MILT ELLER, as his assistant...."

ADDITION INFORMATION ABOUT JOHN ELLER

It is interesting that John Eller's Regiment was in the last battle of the Civil War. This battle was fought in Texas where shortly afterwards Private Eller was discharged from the Union Army at Brownsville, Texas.

The following contains excerpts and summarizations from a back issue of American Civil War Magazine entitled "War's Last Battle." The article primarily follows the personal and military life of Confederate officer John Rip" Ford up to the last battle.

Ford gathered troops where he could, absorbing small units and commanded a Texan Cavalry of 2000 men. These troops were used to take, defend, and hold Brownsville, Texas. Brownsville was an important Confederate port where international shipping brought much needed material and supplies in exchange for cotton and other southern products. Not only did the Confederate units have to fight the Federal troops, but also contend with French and Mexican forces.

A controlling terrain area was Palmito Hill just outside of Brownsville. It was here the unfortunate, unnecessary last battle of the Civil War was fought. The battle was forced by an inexperienced Union officer who broke a truce and orders by moving his troops to the base of the hill. Theodore H. Barrett, Colonel of the 62nd Infantry spoiled the honorable, no lose surrender the Union forces were trying to obtain from Ford and the Confederate forces. Controlling the 34TH INDIANA REGIMENT, and a New York Regiment, Morton Fifies; and some Texas cavalry, Barrett advanced his entire command up to the hill and was stopped May 12, 1865. As he moved his troops through the cannon smoky fog Ford, who had been alerted, hid his cavalry, moved a brace of French cannon up the hill to join the Confederate artillery, and flanked the Union troops. Once in position, 300 horsemen charged the Federal flank and the battle began.

The 34TH INDIANA REGIMENT and the New York Regiment were shattered and over run. They retreated battling towards the sea; trying to

regroup to fight without success. As night fell the Union forces remaining were literally retreating into the sea where the colors of the 34th Indiana Regiment were taken from the bearer. Of 300 men in the unit, 220 were killed. Ford did not lose one man.

Sadly; a few days later Ford got news that Lee had surrendered over a month before the battle.
